

MEMBERSHIP INFORMATION

Memberships are currently being offered through the following packages:

- **Family Membership – Full Payment** **Rs. 560,000/-**
- **Family Membership - Installment Basis** **Rs. 630,000/-**
(14 Monthly Installments of Rs. 45,000/- Each)

All memberships under the above packages are Life-time & Transferable & only cover self, spouse & unmarried children up to 27 years of age. Apart from the membership dues, Monthly Subscription is charged at **Rs. 2500/- per couple** (husband & wife) & **Rs. 600/- per child** above 04 years of age & covers usage of all facilities at the resort. Catering charges are however billed as per consumption.

POLICIES

- Membership covers self, spouse & unmarried children up to 27 years of age.
- The membership fee is not refundable.
- Members' married children or children above 27 years of age may apply separately for "Associate Membership" by paying the prevailing Associate membership fee.
- The member has the right to transfer the membership to another person subject to the acceptance by the management and upon payment of prevailing transfer fee. Upon approval / acceptance the transfer shall be made by canceling the card issued to the member, his / her spouse and children. A fresh card will then be issued to the transferee member, subject to clearance of all dues.
- The management shall under no circumstances be liable or responsible for any accident, loss of life or property to the cardholder, spouse, children or any other accompanied guests introduced by the said cardholder, which may occur within the premises of The Oasis Golf & Aqua Resort.
- Membership cards are issued for the specific use by the member only. Those cards in possession of any person other than the member are liable for confiscation. Members are requested to refrain from lending out their card to anybody to prevent misuse / mis-representation of their card / themselves.
- Membership cards found being misused by any person other than the members' his/her own self will lead to confiscation of such membership card & initiation disciplinary action against the concerned member, which may include suspension of membership for a specific period of time.
- Members who proceed abroad for an extended period can have their membership marked as 'Absentee'. Documentary proof with regards to a members stay abroad will also be required to mark the membership as Absentee
- For the comfort of our fellow members, only limited guest permissions are facilitated through the Member Portal link, our website <http://www.theoasis.com.pk> through Oasis app, available on both Android & iOS (Key word: The Oasis Golf).
- While visiting the resort, proper dress code is to be followed at all times by all members & accompanying guests.

TERMS AND CONDITIONS

- No application shall be entertained without the prescribed payment. The management reserves the right to accept or reject the application and in case of non-acceptance, the payment made will be refunded to the applicant.
- On acceptance of the application, the successful applicant, his /her spouse and unmarried children up to 27 years of age shall be issued "Oasis" cards, permitting them usage of the facilities at The Oasis Golf & Aqua Resort.
- Member's married children or children above 27 years of age may separately apply for the "associate membership" along with the prevailing associate membership fee.
- The membership fee is non refundable. However the member shall have the right to transfer the membership to another person, subject to the acceptance by the management and upon payment of the prevailing transfer fee. Upon approval / acceptance, the transfer shall be made by cancelling the card issued to the member, his / her spouse and children. Fresh card will be issued to the transferee member & his family, subject to clearance of all dues by the previous member.
- The management shall send monthly bills of the preceding month to the cardholder for payment of charges and liabilities caused by the cardholder. Cardholder shall immediately clear the said bills during that month. Non-receipt of the bills shall be no excuse for non clearance and it shall be responsibility of the cardholder to request for a duplicate bill in case of non-receipt of monthly bill.
- Security deposit shall be available for the utilization by the company for it's business purposes including the resort development and operations and adjustment against any normal wear and tear or damages to the properties of the resort at company's own discretion without any reference to the member.
- The cardholder shall not violate the terms and conditions of membership and the rules of use of the facilities nor abuse any facilities offered by the management. The cardholder shall not have any right of interference in the administration / management of the resort in any manner whatsoever in case of which the management shall be at liberty to suspend or cancel the card of the card holder at its entire discretion.
- The management shall have the option and the right to recall the card from the possession of the cardholder or cancel his / her membership without assigning any reason.
- That the management shall under no circumstances be liable or responsible for any accident, loss of life or property to the cardholder, spouse, children or any other accompanied guests introduced by the said cardholder which may occur within the premises of The Oasis Golf & Aqua Resort.
